### IN THE MATTER OF an application dated January 15, 2009 by Enbridge Gas New Brunswick for a Revenue Adjustment / Board Reference: 2009-003-02-01

The Board acknowledges receipt of Enbridge Gas New Brunswick Inc.'s (Enbridge) rate reinstatement application for a partial reinstatement of its distribution rate for the SGSRE class and rate riders for the SGSRO, SGSC, GS, CGS, LFO, OPS and CLVOPS classes.

The Board has considered Enbridge's application, approves the changes to those rates effective on February 1, 2009. The Board also orders the company to adjust the NGVF rate to the same rate as the GS delivery rate.

The approval is conditional on the company notifying customers through the On-Bill message and website notice proposed in the application. The message should be amended to include the change in the NGVF rate.
