

NEW BRUNSWICK ENERGY AND UTILITIES BOARD

IN THE MATTER of an application by Enbridge Gas New Brunswick Limited Partnership regarding the approval or fixing of rates and tariffs pursuant to section 52.2 of the *Gas Distribution Act, 1999*

Order

WHEREAS Enbridge Gas New Brunswick Limited Partnership (EGNB) has applied for a variance of the New Brunswick Energy and Utilities Board (Board) decision dated September 20, 2012 and the decision Addendum dated September 26, 2012. EGNB has also requested an interim order effective July 1, 2013;

AND WHEREAS EGNB provided a copy of this application to all registered intervenors;

AND WHEREAS the Board provided intervenors with an opportunity to make written comments on the process to be used to consider this application;

AND WHEREAS the Board has considered both the submission of EGNB and the written submissions of the intervenors;

NOW THEREFORE IT IS ORDERED THAT:

1. The Board will hold a Hearing at the Board's offices, 15 Market Square, Suite 1400, Saint John, New Brunswick, on **July 11, 2013 beginning at 9:30 a.m.** This hearing will consider the request for a variance of the Board's decision dated September 20, 2012 and the decision Addendum dated September 26, 2012. There will be no separate hearing or consideration of the request for interim relief.
2. Interested parties may attend and make representations on the application of EGNB.
3. Parties who intend to participate should notify both the Board and EGNB in writing by **July 5, 2013** at the addresses below. In your letter please state the official language in which you wish to be heard.


