

## NEW BRUNSWICK ENERGY AND UTILITIES BOARD

IN THE MATTER of an application by Enbridge Gas New Brunswick Limited Partnership regarding the approval or fixing of rates and tariffs pursuant to section 52.2 of the *Gas Distribution Act, 1999*

### Order

WHEREAS Enbridge Gas New Brunswick Limited Partnership (EGNB) is required, pursuant to section 52.2 of the *Gas Distribution Act 1999*, to file an application regarding the approval or fixing of rates and tariffs for the distribution of natural gas on or before May 31, 2012;

AND WHEREAS the New Brunswick Energy and Utilities Board (Board) is required to make an order approving or fixing rates and tariffs for the distribution of natural gas on or before September 30, 2012;

#### NOW THEREFORE IT IS ORDERED THAT:



1. The Board will hold a Pre-Hearing Conference followed by a Technical Session at the Board's offices, 15 Market Square, Suite 1400, Saint John, New Brunswick, on **May 8, 2012 beginning at 9:30 a.m.**
2. Interested parties may attend and make representations about the procedure to be followed, the issues to be considered and any other relevant matters.
